SOLICITATION AMENDMENT 001

This solicitation amendment 001 is raised to provide this question and answer set 1.

Q1.

Regarding the Supply Arrangement, E60MC-190001, it was stated that all builds must comply with the Canadian Coast Guard Welding Specification: CT-043-EQ-EG-001-E from August 2017. However, so far the solicitations that have come out have said this specification does not apply to the build. In fact, some of them seemed to not be aware of this portion of the supply arrangement that made the CCG welding specification a requirement. Is it possible to have some sort of amendment issued noting which builds will actually require this? As we currently have to ask every solicitation about this specification to confirm whether it will be used or not as the requirement adds several thousand dollars to a project and it needs to be clear so that all bidders are on an even field and bidding on the same items.

PSPC in collaboration with partner departments is in the process of developing a Technical Statement of Requirement (TSOR) template to standardize TSORs for this supply arrangement across government and across Canada. The required welding specifications will be incorporated as a statement in this new template.
