PART 1 – SOLICITATION AMENDMENT 002

1.1 Amendment 002

Solicitation Amendment 002 is raised to address the following:

Question/Comments:

We have read your invitation to tender and we are interested in submitting a proposal. We want to inform you that according to the technical description submitted in this application it will not meet the standards of an institutional greenhouse located in St. John's, NL.

Please find below the comments of our Engineer.

1) (Article 19) For St. John's Design Criteria: Even though I apply a slope coefficient C_s for the calculation of the snow load, I do not get the $S = 2.09$ kPa. I would like to know the calculation parameters to get 2.09 kPa please.

2) (Article 18) The required wind pressure (0.6 kPa) corresponds to the 10 year period. For a commercial or institutional greenhouse, we must use the 50-year period which corresponds to 0.78 kPa. It's windy friends!

3) (Article 11) We ask for a spacing of the arches of 4 inches whereas it was surely 4 feet. Nevertheless, for an institutional 30 ft. Greenhouse, setting arches of 2 "x 3-9 / 16" 14ga does not even meet 2.09 kPa unless you add tubular reinforcements. For institutional greenhouses, we prefer to work with the 2-3 / 4 " x 4-5 / 16 " 14ga. It is the snow load calculation that will determine the roof design.

Answer:

Our specifications were developed through many consultations with industry in our area. Recommendations on specifications were developed based on what worked on various farms and what did not work. These specifications were developed based on minimum requirements to ensure all suppliers had a fair chance to bid. Anyone who can meet or exceed these minimum specifications are welcome to bid.
