This solicitation amendment 001 is raised to address bidders questions.

Question 1:

There is no mention of ambulatory seats in the wheelchair transport area (behind the carrier). Does this mean that there will be no outpatient seats for escorts at the back and only the driver and passenger seats at the front?

Answer:

That is correct, no ambulatory seats are necessary for the escorts at the back.

Question 2:

Vehicle specifications indicate Bluetooth among the options. Is it mandatory / preferable for an OEM option or after-sales service installed by a dealer would it be acceptable?

Answer:

This device is a mandatory specification. It is acceptable to have the Bluetooth after-sales service installed by a dealer.

Question 3:

Barrier - as it will be placed through the wheelchair attachment area on the lowered floor (which is lowered to almost one foot from the floor of the original builder's floor), what are the maximum allowed or deemed safe spaces / acceptable from any part of the floor or roof of the vehicle and the barrier?

Answer:

The maximum space allowed is two (2) inches around the barrier. The two (2) inch maximum space must only be increased in areas where it's absolutely necessary for the safe deployment of a side curtain airbag.
