QUESTIONS AND ANSWERS

Question 1: The RFP notes in section PD 4.14.2 that the consultant is responsible for "**installation**" of specialty equipment including Audio/Visual, Security and IT. Note, The "**installation**" portion of those systems alone would be in the order of 10-15% of your Construction Budget. We believe the word "**installation**" should be removed completely.

Answer 1: "Installation" is referenced relative to the requirement to coordinate activities for BCC. The consultant will not be responsible for the actual installation of BCC components.

Question 2: Can you confirm that the "installation" is the responsibility of the contractor and not the consultant?

Answer 2: Confirmed. Installation is provided by the contractors, or in some cases, the vendors of specific products (eg. furniture).

Question 3: The RFP notes in section PD 4.14.2 that the consultant is responsible for "**Design**" of specialty equipment including Audio/Visual, Security and IT; however, in section PD 5.1.2 it is noted that the "**Acquisition**" is the responsibility of BCC (which is typically the case). PD 5.1.2 means that BCC (and their vendor (if any)) will agree on a design and specification and the consultant scope would be to coordinate that on the drawings. Similarly for security, RCMP BTSS would do the design and the procurement and all the consultant have to do is coordinate the electrical requirement and BTSS design with our design team. Can you confirm that the consultant is only responsible for Coordination of AV, Security, and Communications?

Answer 3: The consultant is responsible for the design of all systems outlined in this section. In some cases, such as security, coordination is required with the RCMP's internal specialists for this area, who will provide design guidance and direction with respect to product specifications. The same would hold true for network and telephony systems.
