Section 1: Questions and Answers

Note: Questions are numerically sequenced upon arrival at PSPC. A question and its answer will be provided via BuyandSell as the response becomes available. Potential Offerors are therefore advised that questions and answers may be issued via BuyandSell out of sequence. The following questions have been received. In accordance with Article 13 of the 2006 Standard Instructions – Request for Standing Offers – Goods or Services - Competitive Requirements (2019-03-04), which has been incorporated into the RFSO, the questions and corresponding answers are provided to all potential Offerors as set out below:

Question 1:

I am requesting clarification to the Mandatory Requirements outlined in Attachment 1 to Part 4.

Please confirm that a Contract Nurse must have delivered the minimum number of cumulative regular working hours in Remote, Isolated or Semi-Isolated First Nations communities (Alberta, Manitoba, Ontario, Quebec) as listed in Appendix A only. If this is the case essentially ISC is looking for Offeror's who only have experience working with ISC and formerly Health Canada.

Answer 1:

Canada confirms that under the A-M2, M-M2, O-M2, Q-M2, A-M(NP)2, M-M(NP)2, and O-M(NP)2 criteria the Offeror must demonstrate that the services delivered were obtained in one of the Remote, Isolated, or Semi-Isolated First Nations communities listed in Appendix A to Attachment 1 to Part 4.

First Nations Nursing Stations provide a unique and sometimes challenging working and living environment for Contract Nurses. It is therefore critical that the Offeror has experience screening, training and otherwise preparing capable Contract Nurses to function successfully in these locations with minimal transition and minimal supervision. ISC does not have insight, nor will they be reviewing or approving, any Offeror's contact nurse training program as part of any resulting Standing Offer. Instead, Offerors must assume the responsibility for validating Contract Nurse qualifications and their preparedness to deliver nursing services to the Remote, Isolated or Semi-Isolated First Nations Community prior any Contract Nurse delivering Work under a Call-up.

ISC has determined that for patient care and safety, as well as for the wellbeing of the Contract Nurse, that the Offerors have existing familiarity and hands-on experience providing Contract Nurses for work in a First Nations health care setting, or Isolated Posts, and that Contract Nurses are able to fill the requirements and responsibilities required of them in the nursing station upon arrival. With the above in mind, ISC has further expanded the list of communities accepted under the above referenced criteria to also include Isolated Posts as defined by the National Joint Council.

Please refer to RFSO modification #8.

Question 2:

Section 6: Requirements of Contract Nurses, b) Certification Requirements at Task Authorization Stage states that all proposed CNs must hold valid certification in ITLS. Will Canada accept the Trauma Nursing Core Course (TNCC) credential as a viable substitute for ITLS certification?

Answer 2:

No, ITLS is the only acceptable certification.

First Nations Nursing Stations provide a unique and sometimes challenging working environment for Contract Nurses as Nurses are often the only health service providers, working in pairs or small groups, often with little to no support from other health care professionals. While Trauma Nursing Core Course (TNCC) and Advanced Trauma Life Support (ATLS) course materials are similar to the International Trauma Life Support (ITLS) course material, ITLS is the ISC standard for its Nurses and is the requirement for all Contract Nurses. ITLS is preferred as the materials and focus are more strongly linked to the work environment found in a First Nations Nursing Station where other healthcare professional “supports” may not be available; ISC is of the determination that the ITLS certification best prepares Nurses to work in First Nation Nursing Stations. TNCC is more focused on an emergency room setting where other “supports” are consistently present and is therefore not sufficient preparation for this unique environment.

Question 3:

In regards to Section 3.1: Offer Preparation Instructions, what information is required for Section IV: Security? Is a statement sufficient?

Answer 3:

Offerors are requested to include the level of organization security clearance currently held by their company (and the associated Contract Security Program clearance number) as part of their Offer Submission Form (Attachment 1 to Part 3) that is submitted as part of their offer.

Offerors who do not currently hold a valid organization security clearance through the Contract Security Program should submit a request for sponsorship to TPSGC.PASACOCSI-APISCNSSO.PWGSC@tpsgc-pwgsc.gc.ca

Question 4:

When is the start date for service delivery?

Answer 4:

The start date for service delivery will be determined at the time of Call-up, and subsequent Task Authorization, as issued under any resulting Standing Offer.

Question 5:

Will Canada consider extending the solicitation closing date beyond the current deadline set for October 8th, 2019?

Answer 5:

Canada does not anticipate extending the solicitation closing date beyond October 8, 2019 at 2pm EDT.

Question 6:

In reference to Part 7 – Standing Offer and Resulting Contract Clauses, page 36, clause A 7.11.2 B i, ii and iii, what time period are any failed to comply tasks counted for? Will it only be for the original Period of the Standing Offer of one year from the date of SO issuance and then it restarts for each additional option year or will it be for the entire Period of the Standing Offer regardless of the option years exercised?

Answer 6:

The terms of article 7.11.2 B apply throughout the entire Period of the SO including any extensions that are made to the Period of the SO as a result of Canada exercising an option under article 7.4.2.

Question 7:

In reference to Part 7 – Standing Offer and Resulting Contract Clauses, page 41, For clause B 2.3.2.1 what are the anticipated response timeframe parameters? 4 hours for the exceptional urgent response seems feasible however this timeframe will be challenging if applied for all TA Group Invitation response requests.

Answer 7:

Canada does not anticipate applying the 4 hour minimum deadline to all TA Group Invitation response requests.

Any resulting SOs will be used as a backup mechanism to obtain nursing services when the primary contractor for that Region is unable to provide service. As a result, there is a higher likelihood that the ISC nursing requirements obtained under the SOs will be needed on an urgent basis. However, the 4 hour deadline specified in article 2.3.2.1 is the minimum deadline that will be applied in urgent situations. The Task Authorization Authority (TAA) may provide a longer alternative TA Group Invitation response deadline (specified in the TA Form) and will do so at their discretion, on a case by case basis, taking into account the date of the TA Group Invitation and the Period of Service start date for the Task Authorization.

Question 8:

For clause 2.3.2.2 (page 42) what is the recommended course of action if a contractor plans to propose more than one resource for a TA Group Invitation response?

Answer 8:

The Contractor must not propose more than one resource as part of its response to a TA Group Invitation.

Proposed resources must be available for the entire Period of Service as identified in the TA Group Invitation. Once a qualified resource has been accepted by Canada as a Contract Nurse to perform Work on a Task Authorization issued under a Call-up, the Offeror must make that resource, or a replacement available to complete the specified Work for the entire period as specified in the authorized Task Authorization in accordance with article 08 of the 2035 General Conditions (as amended at article 3.1.1 of B. Resulting Contract Clauses). Failure to do so will result in potential set aside of the Offeror's SO as detailed in article 7.11.2.

If the Contractor proposes more than one resource in response to a TA Group Invitation (i.e. multiple resources that are each available for the entire TA Period of Service), then ISC will only assess one of the proposed resources chosen at the TAA's sole discretion.

Question 9:

For clause 2.3.2.7 A ii (page 43) what reference information is being verified at this stage in the process? The minimum timeframe for the reference to respond is shown as 2 hours, what is the maximum time allowed?

Answer 9:

As part of Canada's evaluation of a Contractor's TA Group Invitation Response the TAA has the right to Contact any or all of the references supplied, at the sole cost of the Contractor, to validate any information submitted by the Contractor as part of that TA Group Invitation Response.

The SO clauses and conditions do not dictate a maximum timeline that will be provided for references at the TA Group Invitation Response evaluation stage. The TAA has the right to provide a longer period of time for the Contractor to provide the requested information. The TAA will do so at their discretion, on a case by case basis, taking into account the date of the reference check request and the Period of Service start date for the Task Authorization.

Question 10:

Regarding Appendix I – Contract Nurse (CN) Scoring Rubric. Will this document be required each time a resource is proposed even if the resource was recently proposed and no change in certificates etc. has transpired? Will all certificates be required to be sent each time?

Answer 10:

Yes. In accordance with article 2.3.2.1, (4) a completed Appendix I to Annex A detailing the Contractor's anticipated proposed CN Score is required as part of a TA Group Invitation response.

The content of the CN Scoring Rubric will vary for each TA (based on the work requirements) and will be determined by ISC prior to issuance of a TA Group Invitation. At a minimum, the CN Scoring Rubric will include the mandatory CN requirements as stipulated in section 6 of Annex A, however ISC may include additional mandatory CN requirements or asset elements dependent on the specifics of the Task Authorization. As a result, a response to each specific CN Scoring Rubric that is raised through the TA Group Invitation process is required.

In addition, in accordance with article 2.3.2.1, (3) the necessary information and documents required to demonstrate that the resource meets all the mandatory requirements specified in Annex A of the Contract is also required as part of a TA Group Invitation response; ISC does not intend on holding individual resource information on file for the purpose of using it for future TA Group Response evaluations.

Question 11:

We would like to participate as an Offeror for the Request for Standing Offer 5A090-192272/A.

Is there a procedure to follow for this or can we simply submit our offer?

Answer 11:

Offerors should read the RFSO in its entirety and must ensure that their offer meets the solicitation requirements in order to be declared responsive.

Offers must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit, electronically, by the date, time and place indicated in the RFSO. Canada requests that all offers are submitted using epost Connect. Please refer to article 2.1 and 2.2 for further details on submitting an offer using epost Connect.

Offers submitted directly to the Standing Offer Authority will be rejected and will and will not be evaluated.
