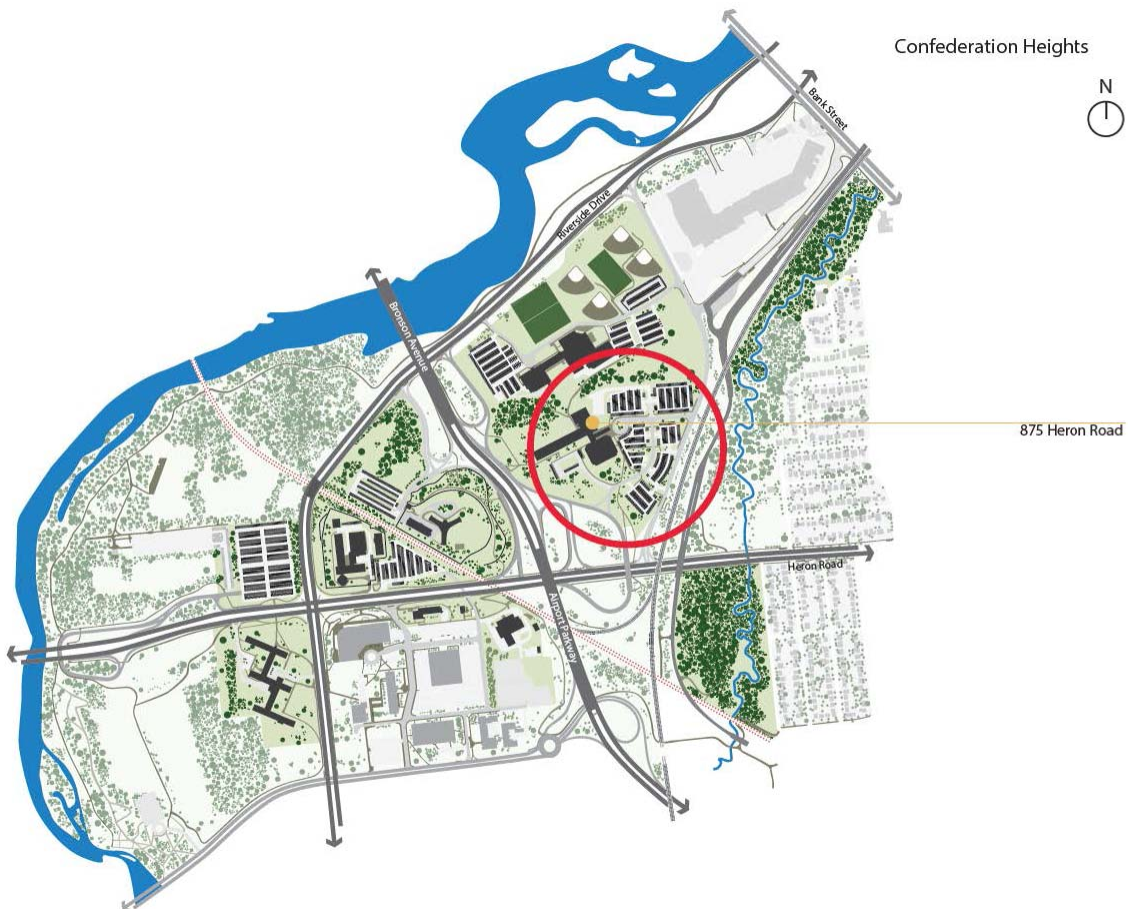


Figure 1 - The Ottawa Taxation Complex, 875 Heron Road, Ottawa (shown in red circle)
