### **Questions 3**

For example, the OAA appears to require that all members of a joint venture performing architectural services be licensed in Ontario (see PT.31, 12/15/2015).

### **Response 3**

Work arising from this contract will only occur in the Province of Ontario. Any firms performing professional acts such as architecture or engineering are required to comply with all Ontario laws and regulations governing their respective professions. Professional licensure in provinces other than Ontario is not a requirement of this contract.
