Question 1:

Requirement 8 of Annex A states that the system must be connected to a cellular network that is secure. Cellular network must have a minimum 3G connection.

There is nowhere in the pricing table, Annex B, Basis of Payment, where the cellular rate plan can be included. Can you advise where this should be provided?

Response 1: The "Monitoring Program" is the place to carry the cellular plan, in Section 1 and 2.
