Amendment 004 to the Letter of Interest (LOI).

The purpose of this amendment is to provide an update on the progress of the RPAS for NASP procurement.

It has been just over a month since Canada concluded One-on-One meetings with potential bidders as part of Industry Engagement. Follow-up feedback was requested from meeting participants for September 13th. The RPAS for NASP project team is assessing the feedback received and determining outcomes to finalize the requirement and RFP.

The closing date of this LOI Notice has been extended to October 17, 2019 for the purpose of keeping the Notice open for Canada to post further communications to Industry, including a summary of feedback and outcomes, before issuing the final RFP.
