SI01 INTRODUCTION

1. The Royal Canadian Mounted Police (RCMP) intends to retain a Contractor to provide construction services for the project as set out in this Invitation to tender (ITT).
2. The purpose of this project is for the construction of a new detachment in Norway House, Manitoba. Contractors is to provide standard manufacturer's foundation based on Structural Drawings and Specification for Modular buildings.
3. This is a two phase selection process. Bidders responding to this ITT are requested to submit a bid in two phases. Phase One bids cover only the qualifications and experience of the Bidder, refer to SI06 'Submission of Bid'. Following evaluation of these bids, Bidders are advised of their competitive standing and have the opportunity to decide whether or not to continue their participation by submitting a Phase Two bid. Phase Two bids cover the pricing. A combination of the Phase One and Phase Two submissions constitutes the final bid.
4. Initially, suppliers are invited to submit a bid in the first phase of the selection procedure outlined below. Only the Phase One information asked for in the ITT is to be included in the Phase One bid, and evaluation of Phase One bids will be carried out only on the Phase One information requested.



(B) QUESTIONS AND ANSWERS

1. **Question:** As a prospective bidder do I have to complete the Mandatory requirements in the Invitation to Tender (ITT)?

Answer: Yes, in order for a bid to be deemed responsive the requirements of the ITT must be met including the completion of APPENDIX 1 – PHASE ONE QUALIFICATION FORM. This provides a bidder the opportunity to demonstrate their abilities to meet pre-determined criteria.

2. **Question:** Is alternative transportation outside the ferry require to deliver this modular project?

Answer: No, the ferry runs most of the year, except into the winter months when an ice bridge is opened. All modular units are designed to fit on the ferry and meet all weight and size requirements. Information on the ferry restrictions can be found on the Manitoba Infrastructure Website and the onus is on the bidder to confirm this information.

3. **Question:** Has there been any changes with the design from the previous solicitation 201900733?

Answer: Yes, the previous design had a non-combustible requirement. This requirement has changed to combustible with a number of modifications. The onus will be on the responsive phase one bidders to review the drawing and specification with this solicitation.

4. **Question:** Where is Norway House?

Answer: Norway House is a population centre of over 5,000 people some 30 km north of Lake Winnipeg, on the bank of the eastern channel of Nelson River, in the province of Manitoba, Canada.

5. **Question:** Is there air Service to Norway House?

Answer: Norway House is served by Perimeter / Bearskin Airlines with 4 flights daily. Various other charter services also serve the community.

6. **Question:** Are there services available in this community?

Answer: Norway House has several restaurants, two hotels, a Royal Bank branch, two Northern stores, a full service post office, two video stores and paved roads within the community. The Kinosao Sipi Mall and the recently-added cell phone service are improvements to this northern community, as well as Norway House Cree Nation (NHCN) Broadband Internet. Norway House is served by the Royal Canadian Mounted Police and the NHCN Band police.

7. **Question:** Is there a web site I can refer to?

8. **Question:** As the successful bidder am I able to set up a trailer on site for accommodation or an office?
