The following revisions supersede the information contained in the original drawings and specification issued for the above named project, and shall become part thereof. No consideration will be allowed for extras due to the contractor or any subcontractor not being familiar with this Addendum.

1. QUESTIONS AND ANSWERS

Q1: Electrical - Is there a fixture schedule?

A1: Luminaire schedule is in the specification 26 50 00.

Q2: Electrical - Water sensor, electrical contractor to connect...What is this and where do is connect to?

A2: The water sensor is to be connected to the elevator controller. Electrical contractor to coordinate with the elevator and the mechanical controls trades.

Q3: Electrical - Can the ground wire for room 2013 go to a closer ground bus than the main electrical room?

A3: Grounding system to be installed as per the tender documents. No alternate solution will be considered.
