Upon award of contract in Phase Two the pre-qualification list will be terminated, no additional contracts will be awarded.



INSTRUCTIONS TO BIDDERS

1. This is a two phase selection process. Bidders responding to this selection process are requested to submit a bid in two phases. Phase One bid covers only the qualifications and experience of the Bidder. Following the evaluation of the submissions, Bidders will be advised of their standings. Phase Two Bidders will be provided an Invitation to Tender (ITT) for the financial evaluation in relation to the specifications and drawings. Please refer to sample ITT attached.

APPENDIX 1 – PHASE ONE QUALIFICATION FORM

Description:

This project is the demolition and rebuild of a prefabricated shed at a radio communications tower. It involves the demolition and removal of an existing metal sided shed that contains asbestos containing materials and existing chain link fencing. The project involves site preparation including site grading and piles, the construction of a new pre-fabricated shed, and installation of new chain link fencing around the perimeter of the site located at Gordon, MB.

Bidder Instructions: The Bidder is requested to respond to the Phase One Evaluation Criteria using the table below.
