PART 1 - GENERAL INFORMATION

1.1 Introduction

The bid solicitation is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications: includes the certifications to be provided;
- Part 6 Security Requirements: includes specific requirements that must be addressed by bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

The Annexes include the Statement of Work, the Basis of Payment, Security Requirements, and any other annexes.

The Appendixes include the Evaluation Criteria and the Financial Proposal Form.

1.2 Summary

By means of the RFP, Natural Resources Canada (NRCan) is seeking proposals from bidders for a project to expand the knowledge of toxicity with aquatic plants, algae, and fish to establish effect concentrations for four priority lanthanides: Lanthanum (La), Cerium (Ce), Neodymium (Nd) and Yttrium (Y). A proposed testing methodology has been provided in this requirement.

The contract period will be for 6 months, or until March 20, 2020. There are no security requirements.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.



PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.


The onus is on the Bidder to ensure that the proposal is delivered to the location above. Not complying with the above instructions may result in NRCan's inability to ascertain reception date and/or to consider the bid prior to contract award. Therefore, NRCan reserves the right to reject any proposal not complying with these instructions.

2.2.1 Due to the nature of the bid solicitation, bids transmitted by facsimile or electronic mail to NRCan will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 7 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the



2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Improvement of Requirement during Solicitation Period

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. 
Section I: **Technical Bid**

In their technical bid, Bidders should demonstrate their understanding of the requirements contained in the bid solicitation and explain how they will meet these requirements. 4.1 Evaluation Procedures

4.1.1 Technical Evaluation

4.2 Basis of Selection

4.2.1 Highest Rated Within Budget

- 1. To be declared responsive, a bid must:

5.2.2 Federal Contractors Program for Employment Equity - Bid Certification

By submitting a bid, the Bidder certifies that the Bidder, and any of the Bidder's members if the Bidder is a Joint Venture, is not named on the Federal Contractors Program (FCP) for employment equity "FCP Limited Eligibility to Bid" list (http://www.labour.gc.ca/eng/standards_equity/eq/emp/fcp/list/inelig.shtml) available from Employment and Social Development Canada (ESDC) - Labour's website.





SW1. TITLE

Algal Fish Fate Testing.

SW2. BACKGROUND

In recent years, a steady, reliable, and secure supply of critical metals has become increasingly important to major industrialized economies that seek to sustain their industrial base and develop advanced technologies, such as clean energy. In light of this, Canada, with its significant critical metal reserves, has an opportunity to supply some of the global demand for critical metals. However, to transition from promising mineral deposits to marketable products, investment in fundamental R&D and expertise is needed to address the complex technological challenges around the production, separation and processing of critical metals, and to better understand the global market for these key commodities.

Rare Earth Elements (REE) represent an opportunity for Canada to enter an emerging and globally strategic market. However, the metallurgy for Canadian ores containing REE involves a complex sequence of individual separation, refinement, alloying and formation stages before they can be used in the production of permanent magnets, consumer electronics and other high value-added high-tech products.

Natural Resources Canada has been directed through Budget 2015 to undertake a significant effort to support the development of Rare Earth Elements and chromite in order to maximize Canadian value and benefits from these deposits.

SW3. OBJECTIVE

The present knowledge of potential eco-toxicological effects of REEs is limited, specifically chronic toxicity data are underrepresented. Therefore, the objective of this project will be to undertake further toxicity tests with aquatic plants/algae and fish to establish effect concentrations for four priority lanthanides: Lanthanum (La), Cerium (Ce), Neodymium (Nd) and Yttrium (Y).

SW4. PROJECT REQUIREMENTS

SW4.1 Tasks

Under the guidance of CanmetMINING, the Contractor will need to:

- 1) Conduct three (3) aquatic plant/algae chronic toxicity tests with La, Ce, Nd and Y. The following are a list of preferred species with reference to suggested test methodology.
 - a. Lemna Minor growth test1;
 - b. Raphidocellis subcapitata green algal growth inhibition test²;
 - c. Chlorella sp.- growth inhibition test³.
- 2) Conduct chronic Brown Trout growth and survival test with Ce. See footnote 3 for a reference to a suggested test methodology

- 3) Conduct an investigative fate assessment to understand the influence of food additions on REE solubility. Specifically, assess the change in dissolved concentrations of La, Ce, Nd and Y over time with the addition of standardised food (e.g. trout chow, diatoms etc.). The specifics and design of the test is open for discussion but a requirement for these tests is to have temporal data (e.g. 1hr, 4hr, 8hr etc) to assess the change in solubility during a toxicity test to better understand bioavailability.
- 4) Conduct water sampling at regular intervals throughout the tests for REE analysis (dissolved/total). Specifically for the fate assessment, sample test water at 1hr, 4hr, 8hr, 12hr and 24hr at least three times during the duration of the test to analyse for total and dissolved REEs. Conduct analysis of pH, phosphate, calcium, ammonia, magnesium and sodium.

It is recommended that a soluble salt of the metal be used to reduce influence on the chemical speciation.

The contractor will need to produce a report that includes the algal/plant species to be tested, the approach used, including reference to the toxicity methods used, and calculation of effect concentrations for the four lanthanides: La, Ce, Nd and Y. A clear explanation of any assumptions used and calculations made must accompany any data provided. The report must include raw data as well as a clear explanation of how the test met all requirements for validity, including water quality parameters (e.g. temp, DO, pH, ammonia) measured throughout the test.
