### 2. Questions and answers 13 and 14

#### Question 13

Please advise the height of the respective drains in each shower compartment as well as their location (center or corner of stall). Also, if possible specify the % of slope required (1, 2, 3.....).

#### Answer 13

Here is the position information of the shower drains:

Officer showers: see fr108-116 upper deck: two drains: an 8" to 18x6 at the inner corner and a 4" to 16x5 at the outer corner.

Nurse shower: see fr42-47, starboard upper deck, 4" drain at the outside corner, 9x9.

Boson shower cab 36: drain at the outside corner, 6 x 5.5.

Officers' showers, see fr113-120, officers' deck, 4" drain at the inside corner, 9 x 5.

For the height of the drains, we do not have this exact measurement. We can consider 0.5" to 1".

For the slope it is about 3%.

#### Question 14

Would it be possible to have the thickness of the existing underlayment of the areas?

#### Answer 14

We do not have the exact thickness, we believe it is between 0.5 and 2 inches.

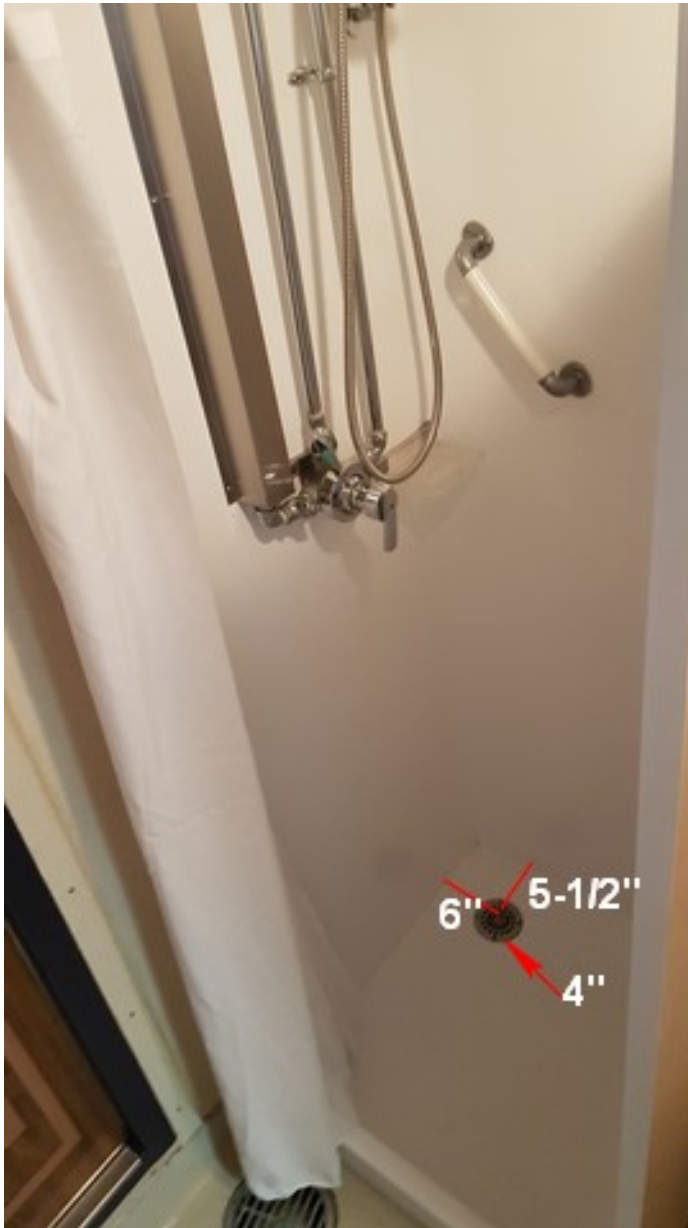

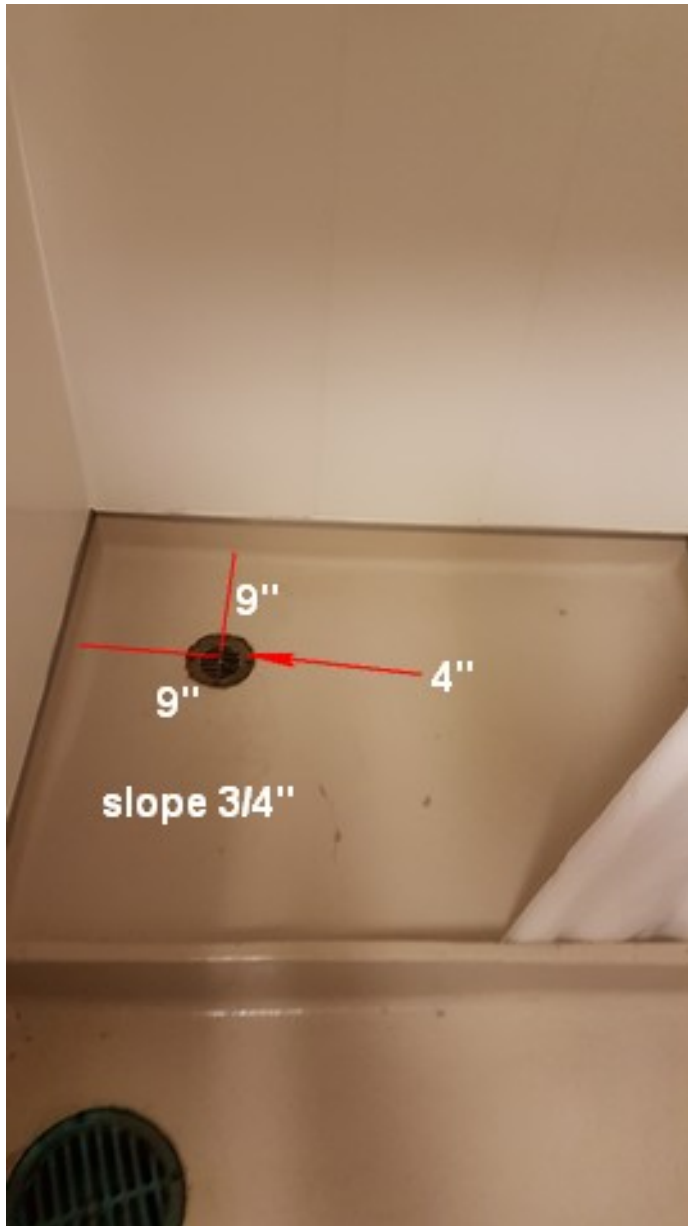
