SOLICITATION AMENDMENT 002

This Amendment is raised to:

- (a) Address questions raised by industry; and
- (b) Revise the solicitation.

Question 1:

Can the solicitation closing date be revised to a later date?

Response to Question 1:

The solicitation closing date has been revised as reflected on the cover page of this solicitation amendment. Unfortunately due to several constraints including the availability of the vessel, a longer extension will not be considered at this time. The enquiry period will not be extended.

Question 2:

With respect to the References in Annex A (Statement of Work), not all of the drawings appear to be available at the links provided. Can you please confirm their availability?

Response to Question 2:

The file found at <ftp://ftp.dfo-mpo.gc.ca/campbellc/SirWilfredGrenfellStructuralDrawings.zip> has been updated. Please download the file again.

Question 3:

What is the purpose of two site visits?

Response to Question 3:

One of the purposes of Site Visit #1 is to provide the Contractor an opportunity to compare the drawing package and references with the actual vessel and sort out any potential discrepancies, before they invest a lot of office time.

One of the purposes of Site Visit #2 is to provide the Contractor an opportunity to make sure that they arrived at workable solutions, or for a second field check before completing the work, if the Contractor thinks that will be necessary.

Revision 3:

In Article 2.6 (Enquiries – Bid Solicitation),

Replace:

“All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.”

with the following text:

“All enquiries must be submitted in writing to the Contracting Authority no later than October 4, 2019. Enquiries received after that time may not be answered.”.

Revision 4:

Replace:

Article 4.1.2 (Financial Evaluation) in its entirety

with the following text:

“4.1.2 Financial Evaluation

The following “Evaluated Price” equation will be used to determine the evaluated price of the Bid based on the prices inserted by the Bidder in its bid Annex B (Basis of Payment):

Using the Items listed in Annex B,

Evaluated Price

= Firm Price of Item A
+ Firm Price of Item B
+ Firm Price of Item C
+ (10 x Firm Hourly Charge-Out Labour Rate of Item D)
+ (20 x Firm Hourly Charge-Out Labour Rate of Item E)
+ (20 x Firm Hourly Charge-Out Labour Rate of Item F)
+ (10 x Firm Hourly Charge-Out Labour Rate of Item G).

The factors used in the “Evaluated Price” equation are for bid evaluation purposes only. There is no guarantee that the factored quantities of the Items D, E, F, and G used in the “Evaluated Price” equation will be procured.”.

Revision 5:

Replace:

Article 6.6.1 (Basis of Payment) in its entirety

with the following text:

“6.6.1 Basis of Payment

In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid firm unit prices, as specified in Annex B for a cost of \$_____. Customs duties are included and Applicable Taxes are extra.

Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work, unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work.”.

Revision 6:

Replace:

Annex B (Basis of Payment) in its entirety

with the following text:

“ANNEX B – BASIS OF PAYMENT

B.1 Known Work

In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid the following firm price:

B.2 Unscheduled Work

The Contractor will be paid for unscheduled work arising, as authorized by Canada.

The authorized unscheduled work will be calculated as follows:

Priced in Canadian currency. Customs duties are included. Applicable Taxes are extra.

The above are the Contractor's firm hourly charge-out labour rates which include overhead and profit, plus net laid-down cost of materials to which will be added a mark-up of 10 percent, plus applicable Taxes calculated on the total cost of material and labour.

The firm hourly charge-out labour rates and the material mark-up will remain firm for the term of the Contract and any subsequent amendments.

B.3 Overtime

The Contractor must not perform any overtime under the Contract unless authorized in advance and in writing by the Contracting Authority. Any request for payment must be accompanied by a copy of the overtime authorization and a report containing the details of the overtime performed pursuant to the written authorization.

The authorized overtime work will be calculated as follows:
