**Section 1: Questions and Answers**

Note: Questions are numerically sequenced upon arrival at PSPC. A question and its answer will be provided via BuyandSell as the response becomes available. Potential Offerors are therefore advised that questions and answers may be issued via BuyandSell out of sequence. The following questions have been received. In accordance with Article 13 of the 2006 Standard Instructions – Request for Standing Offers – Goods or Services - Competitive Requirements (2019-03-04), which has been incorporated into the RFSO, the questions and corresponding answers are provided to all potential Offerors as set out below:

**Question 43:**

Would Canada consider extending the solicitation closing date beyond the current deadline set for October 8th, 2019 to allow Offerors extra time to adjust CN roster tallies for all Excel M2, M(NP)2, P(NP)1 and P1 appendices?

**Answer 43:**

The RFSO closing date has been extended to October 11, 2019 at 02:00pm EDT.

**Question 44:**

On page 58 of 69, in Annex B: Basis of Payment, in Travel and Living Expenses section under 1.2:

Will Canada authorize and reimburse travel expenses from the Contract Nurse's principal residence to the Location of Work and then back to the Contract Nurses principal residence at the end of each assignment?

**Answer 44:**

Yes. Canada will reimburse authorized travel and living expenses reasonably and properly incurred in the performance of the Work, in accordance with Annex B, provided that the travel originates from within Canada.

Travel arrangements must be made in accordance with terms and conditions for travel herein and in accordance with the National Joint Council Travel Directive, and with the other provisions of the directive referring to "travellers", rather than those referring to "employees" excluding the reimbursement of meals, bottled water, parking, telephone calls and incidentals.

INSERT:

Canada will reimburse authorized travel and living expenses reasonably and properly incurred in the performance of the Work, at cost, with no allowance for overhead, profit, travel agency fees or consulting fees both to and from the Location of Work. Travel arrangements must be made in accordance with terms and conditions for travel herein and in accordance with the National Joint Council Travel Directive, and with the other provisions of the directive referring to "travellers", rather than those referring to "employees" excluding the reimbursement of meals, bottled water, parking, telephone calls and incidentals.
