## APPENDIX 1 – PHASE ONE QUALIFICATION FORM

**Description:** Work in this contract comprises of interior and exterior renovations at the RCMP Detachment in Iqaluit, NU. The project consists of relocating an existing heating fuel oil tank to the rear of the building, complete with new enclosure and safety bollards. The work also includes installing a new piping system from the new location to the mechanical room, as well as vacating and capping the existing piping. Interior work includes the replacement of the day tank, along with various upgrades to the system design.

Bidder Instructions: The Bidder is requested to respond to the Phase One Evaluation Criteria using the sample table below.
