This amendment is raised to:

A. Answer questions from bidders;

- B. Amend section 6.2 Statement of Work;
- C. Amend Annex B Basis of Payment:
- D. Amend Part 1: Technical Evaluation Criteria of Annex G Technical Evaluation; and
- E. Attach the Basic Impact Analysis (BIA) Cheewaht Lake Tributaries Restoration Project.

Bidders <u>MUST</u> submit their bids in accordance with the amended version of Annex B – Basis of Payment and Annex G – Technical Evaluation contained herein

A. Answer Questions from Bidders

- Q1. Will Parks Canada do either of two things due to the requested fixed price and unfixed scope?
 - Accept a technical proposal that defines limits on the work scope and/or level of effort, acknowledging that additions to the scope of work would be changes to the contract and contract price; or
 - 2. Retract the existing tender and re-tender when a fixed design can be provided as the basis for pricing.
- A1. Parks Canada is unable to accept technical bids that define limits on the scope or work or level of effort in response to this solicitation. The Bidder's technical proposal will form part of the contract. Due to the nature of the work Parks Canada cannot re-tender this project with a fixed design. This is because there are inherent and/or as of yet unresolved uncertainties associated with access to the site(s), their environmental condition (such as bank/slope stability). Parks Canada will require bidders to submit an all-inclusive firm price for the work as defined. Bidders must include necessary contingencies in its financial bid. Work in excess of or outside the scope of the contract that is approved by the Contracting Authority will be addressed via amendment to the contract. Bidders may request clarification to any assumptions it feels are required to submit a financial bid. All questions and clarifications must be distributed to all bidders.
- Q2. The original technical point rated criteria specifies that the bidder must have experience in instream monitoring, environmental data collection, biological and environmental data collection, analysis and summary, monitoring methods including point photo monitoring, fish habitat assessment, and surveying techniques. However, the amended tender specifications (Addendum 4) clarify that these activities will be conducted by the PCA EM Contractor. Can the point rated criteria be amended to reflect the changes?
- **A2.** Please see amended Annex G Technical Evaluation below.
- Q3. Will the Environmental Management Plan (EMP) be made available during the bidding process?
- A3. The creation of the EMP is the responsibility of the EM Contractor who has not been selected yet. The RFP can be found at https://buyandsell.gc.ca/procurement-data/tender-notice/PW-19-00889251.
- **Q4.** Will PCA's EM Contractor be conducting surveys for danger trees, invasive species, bird nesting surveys, etc., or is that the responsibility of the Restoration Contractor?

A4. Danger trees impact health and safety of the Restoration Contractor and surveying for them will be the Restoration Contractor's responsibility. Note that any cutting of trees must be approved by the PCA Project Authority or their designated representative prior to cutting. Surveys for invasive species and bird nests are the responsibility of PCA.

- Q5. The original tender package identifies the requirement to conduct fish salvage & vegetation salvage for replanting (section 3.3.3 & 3.3.4); however, in addendum 4, this section has been removed. The updated sections 3.3.7 & 3.3.8 refer to vegetation salvage & replanting salvaged vegetation. Please confirm that fish & vegetation salvage are no longer within the scope of work.
- **A5.** Fish salvage will be the responsibility of the EM Contractor. Vegetation removal, salvage and replanting will be done by the Restoration Contractor.
- **Q6.** Who is responsible for collecting donor plants and transplanting for habitat complexing, referred to in section 3.3.8, and the salvage/collection of LWD?
- **A6.** If the EM Contractor can identify sufficient donor sites, the Restoration Contractor will do the replanting, otherwise, only salvaged vegetation may be used.
- **Q7.** Is Cheewaht lake accessible by road?
- **A7.** There is no road directly to lakeshore or the restoration sites.
- **Q8.** Where excavated sediment will need to be placed?
- A8. All excavated material will be side-cast and spread out by an excavator in spoil zones on the right bank of each of the channels. Low-lying areas such as the numerous breach channels that flow from the right bank of S 1, 2, and 3 will be the preferred areas for spoil placement. Spoil areas will be adjacent to sites of excavation.
- **Q9.** How high is the creek water level in the summer?
- A9. In the summer water level is relatively low (<= ankle deep) in S1 and the upper section of S2. Water goes subsurface in the lower section of S2 and much of S3.

B. Amend section 6.2 Statement of Work;

Under Part 6 – Resulting Contract Clauses, delete section 6.2 in its entirety and replace it with the following:

Financial Bid Submission Requirements

- (a) Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.
- (b) The Bidder must submit their financial bid in accordance with the Basis of Payment.
- (c) All prices are in Canadian dollars, FOB destination
- (d) Customs duties are included and Applicable Taxes are extra.

1. Firm Price - Contract - Date of Contract to March 31, 2022 inclusive

In consideration of the Contractor completing all of its obligations under the Contract, the Contractor will be paid a firm price in Canadian funds <u>for all costs</u>, including but not limited to all professional, technical, and administrative fees and costs as required to fulfill the requirements of *Annex A – Statement of Work* as defined.

The following is to be assumed:

- Five (5) days of inclement weather where the Contractor cannot perform work under the Contract. The Project Authority must be notified and approve of all such days immediately.
- Excavation cut volumes of 11.000 m³.
- All habitat complexing materials will be sourced from materials set aside during the vegetation salvage and site access phase.
- All habitat complexing materials will be sourced from within 100m of where removed.
- Assume 80 days of crew time to complete in-stream restoration phase for S1, S2 and S3.

Note: Any resulting cost adjustments to the Contract shall be negotiated with the Contractor and must not exceed the all-inclusive firm price as specified below, unless first approved in writing by the Contracting Authority.

- (a) Additional payment terms and conditions will not apply to the contract; and
- (b) Customs duties are included and Applicable Taxes are extra.
