This Revision is raised to answer questions received to date and to modify the Request for Supply Arrangement:

1. Questions and Answers

Question 36

Regarding the PDT – MPR spreadsheet, all Electron microscopes (both SEM & TEM) used to be classified under N6650 – Electron microscopes. This seems equivalent to the UNSPSC code 41111711 – electron microscopes, however the RFSA only mentions SEM, under the 41111720, and does not appear to include 41111721 – TEM. Is this category going to be the subject of a later RFSA or should it be included to this RFSA?

Answer 36

The UNSPSC sub-category 41111721 (transmission electron microscopes), was not requested for this Request for Supply Arrangement, it will not be included in this Request for Supply Arrangement.

Question 37

The RFSA indicates in order for a supplier to be considered responsive and potentially be awarded a Supply Arrangement it must agree to all terms and conditions without making exceptions (Basis of Selection, Section 4.4, bullet 2). Section 1.2.1, last sentence of second paragraph, states that "Supply Arrangements include a set of predetermined terms and conditions that will apply to any subsequent Contract." Is that truly the case or would we be able to negotiate some changes on individual Contracts issued under a Supply Arrangement?

Answer 37

- Please see modification below
- Yes, for a supplier to be responsive to the Request for Supply Arrangement (to be included in the pre-qualified list of suppliers) he must comply with all terms and conditions of the Request for Supply Arrangement.
- The only negotiation you could be able to do, is with a resulting contract under \$25,000 (sole-source, no competition).
