**Question 2:**

The drawing cover page references Photo 2 on A200. That page does not exist in the drawing set. Also pages A101, A102, A200, A201, A202, A203, A204, A205, A206 are missing. Can you please provide these?

**Answer 2:**

This Invitation To Tender (ITT) is for the Supply, Delivery and Installation of Aluminum Clad Vinyl and Fiberglass Windows only, as part of the Masonry Re-point project for the Administration, Multicultural and Chapel Buildings.



The drawing cover page, item #6 – A200 are photos regarding the Repointing portion of the project. Pages A101, A102, A201, A202, A203, A204, A205 all refer to the Administration building which has nothing to do with this ITT window requirement. A206 is already in the package.

The Drawings and Specifications are to be referenced along with the ITT - ANNEX C – SCOPE OF WORK.

The BID AND ACCEPTANCE FORM (BA) indicates how bidders are to submit their proposal for the work identified, STREAM 1 and/or STREAM 2. Bidders must use the BA form to submit a proposal for the work.

**Question 3:**

Is there a bid security or bid bond required for this project?

**Answer 3:**

No there is no bid security or bid bond required for this project.

Note that the following Supplementary Condition will apply to the awarded contract –

**SC03 Terms of Payment – Progress Payment and Holdback**

1. On the expiration of a payment period, the Contractor shall deliver to Canada
  - a. a written progress claim in a form acceptable to Canada that fully describes any part of the Work that has been completed, and any Material that was delivered to the Work site but not incorporated into the Work, during that payment period, and
  - b. a completed and signed statutory declaration containing a declaration that, up to the date of the progress claim, the Contractor has complied with all lawful obligations and that, in respect of the Work, all lawful obligations of the Contractor to its Subcontractors and Suppliers, referred to collectively in the declaration as " subcontractors and suppliers", have been fully discharged.
2. Subject to GC5.2, "Amount Payable", and paragraph 5) of GC5.4, Canada shall pay the Contractor an amount that is equal to
  - a. 90 percent of the value that is indicated in Canada's progress report

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
