#### **Section 1: Questions and Answers**

Note: Questions are numerically sequenced upon arrival at PSPC. A question and its answer will be provided via BuyandSell as the response becomes available. Potential Offerors are therefore advised that questions and answers may be issued via BuyandSell out of sequence. The following questions have been received. In accordance with Article 13 of the 2006 Standard Instructions – Request for Standing Offers – Goods or Services - Competitive Requirements (2019-03-04), which has been incorporated into the RFSO, the questions and corresponding answers are provided to all potential Offerors as set out below:

#### **Question 46:**

There appear to be inconsistencies between some of the Isolated Posts listed in Appendix B to Attachment 1 to Part 4 and the communities suggested under questions and 37 b) and 40. For example, it is unclear why experience in a community such as Ivujivik, QC is not accepted when experience in Blanc Sablon, QC is.

Would Canada reconsider the request made to add additional Remote, Isolated and Semi-Isolated communities to the list of those accepted under RFSO criteria A-M2, M-M2, O-M2, Q-M2, A-M(NP)2, M-M(NP)2, and O-M(NP)2?

#### **Answer 46:**

A pre-defined list of Isolated Posts, established by the National Joint Council, was used to expand the list of acceptable Remote, Isolated and/or Semi-Isolated locations in Amendment 001, modification 8.

Offerors should be aware that not all Remote, Isolated or Semi-isolated locations are equal and that First Nations nursing stations are a unique and often challenging work and living environment for nurses. Nurses are often the only health service providers in stations and access to doctors, hospitals and other health care specialists is limited or only available through a medevac. Contract Nurses must be adequately trained and prepared to work independently and with minimal supervision on arrival in a First Nation nursing station and the Offeror is accountable for assuming all responsibility for validating Contract Nurse qualifications and their preparedness to deliver nursing services in First Nations communities prior to proposing any Contract Nurse in response to a TA Group Invitation.

If a community is not listed in Appendix A to Attachment 1 to Part 4 or in one of the Isolated Posts listed in Appendix B to Attachment 1 to Part 4, then Canada will accept experience gained in communities that meet the definition of a Remote, Isolated or Semi-Isolated Community as defined in Appendix C to Attachment 1 to Part 4, if the Offer submits a Fully Completed Certification for each community submitted for evaluation by the Offeror that is not already listed in Appendix A to Attachment 1 to Part 4 or in one of the Isolated Posts listed in Appendix B to Attachment 1 to Part 4.

Canada has further extended the RFSO closing date in order to allow Offerors to make adjustments to their technical offers accordingly. These modifications have been made to the A-M2, M-M2, O-M2, Q-M2, A-M(NP)2, M-M(NP)2, and O-M(NP)2 criteria only and will not be applied toward the RFSO's point rated criteria.

See RFSO modifications 12, 13, 14, 15, 16, 17, 18, 19 and 20 below.

## Section 2: Modifications to the Solicitation
