## PART 1 - GENERAL INFORMATION

### 1.1 Requirement

The requirement is detailed under Article 6.1 of the resulting contract clauses.

### 1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### 1.3 Trade Agreements

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), and the Canadian Free Trade Agreement (CFTA).

### 1.4 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

## PART 2 - BIDDER INSTRUCTIONS

### 2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2019-03-04) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

**Note:** Bids will not be accepted if emailed directly to this email address. This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

### 2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## **2.4 Applicable Laws**

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## **PART 3 - BID PREPARATION INSTRUCTIONS**

### **3.1 Bid Preparation Instructions**

- If the Bidder chooses to submit its bid electronically, Canada requests that the Bidder submits its bid in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

The bid must be gathered per section and separated as follows:

- If the Bidder chooses to submit its bid in hard copies, Canada requests that the Bidder submits its bid in separately bound sections as follows:

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of hard copy of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

## **5.1 Certifications Required with the Bid**

## ANNEX "A" - REQUIREMENT

Visibility sensors are a key instrument in the suite of sensors deployed by Environment and Climate Change Canada (ECCC) at research sites in the arctic and other sites in Canada. These sensors provide key data on visibility and also can analyze precipitation to determine key parameters such as type, intensity, rate and accumulation. ECCC has a need to acquire visibility sensors to make visibility and precipitation measurements in a variety of environments including the arctic requiring equipment to operate unattended over a large range of ambient temperatures. The need to distinguish between different precipitation types is important and the ability to differentiate between liquid and frozen precipitation near the freezing temperature requires them to be able to make high accuracy temperature measurements.

### Minimum Mandatory Specifications

The visibility sensors must have the following features:

- be pole mounted with the sensor at the 3m level above ground.
- sensor unit weight of less than or equal to 15 lbs (6.8 kg).
- electronics unit weight of less than or equal to 25 kg
- uses forward scatter principle
- report: visibility, precipitation types including but not limited to Rain, Snow, Ice Crystals, Drizzle, Freezing Drizzle, Ice Pellets, Snow Grains, Hail, Fog, Haze, Mist
- report standard WMO and NWS SYNOP and METAR Codes
- report intensity of precipitation (light, moderate & heavy)
- operational temperature range -55C to +60C
- high accuracy temperature sensor (+/- 0.25C over the entire operational temperature range) for freezing precipitation measurements.
- a heated sensor area for cold operation in all weather conditions including frost and heavy snowfall without operator intervention over the operational temperature range.
- measure visibility range from 0 km to a minimum of 75 km
- reported visibility resolution <2m
- reported precipitation intensity 0 to at least 750 mm/hr.
- reported precipitation accumulation 0 to at least 750 mm
- reporting resolution of precipitation <0.02 mm/hr
- sea salt and other corrosion resistance coated components
- have compensation for contaminated optics
- have a battery backup for operation during power failures
- output data in ASCII serial format using a selectable protocol of RS232 or RS485
- measurement cycle <10 s
- user selectable units, sample frequency, data baud rates
- include any required calibration devices
- power requirements: 120 VAC, +/- 10% 60 Hz. <400W (Including Heat)
- include power and signal cables with a minimum length of 5 m
- electronics unit (if separate from sensor unit)
