### 1) Answer Questions From Bidders

**Question 1:** Annex A-Statement of Work 5.4: States boxes and/or plastic moving bins in sufficient numbers to cover each move. You also state this is to be included at no addition cost to the client. However, in Annex B-Basis of Payment Table # 1 Section D, Packing material & Supplies, you are asking for rates for the above materials.

If you are deleting 5.4 of the Statement of Work, then this makes sense. If not, could you provide the number of moves you have per year and how many boxes or bins are needed for each of the individual moves.

**Answer 1:** We need item-specific costs (boxes, plastic bin, tape, stickers etc.) and confirmation of availability at all times. Equipment rental can vary between 24 hours, several weeks and/or the length of the job. As per Annex B- Basis of Payment, Table 1, Section D, item 10, it is indicated that the minimum rental period for the plastic bins is one week.

Please note that, if a contract is issued, it will be Tasks Authorizations (TA) based and the Supplier will have to send an estimate for each request, indicating quantities for the plastic bins and boxes.
