Arrangements have been made to provide Bidders the opportunity to view the vessel.

The Vessel will be available for viewing at CCG Base Huron Street from 09:00 AM to 04:00 PM on October 25, 26, 27, 28, and 29th, and between 09:00 AM and 12:00pm on October 30th.

Participants must indicate to the Contracting Authority their intent on attending the vessel no later 12:00pm the day before they intend to attend the vessel. Participants who indicate later than 12:00pm may not be permitted to attend until 12:00pm the next day.

The Vessel Viewing will be of a limited duration based on times and dates indicated above.

Bidders are requested to register the name(s) of the person(s) who will be attending the Vessel Viewing by e-mailing the Contracting Authority.

Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid.

The Contracting Authority, Technical Authority, and ship staff will not provide answers to questions during the Vessel Viewing. Bidders are invited to e-mail their questions to the Contracting Authority after the Vessel Viewing.

Participants may be required to present valid government-issued photo identification and sign attendance sheets. Participants must comply with all regulations, instructions and directives in force on the site and vessel.

Any clarifications or changes to the bid solicitation resulting from the Vessel Viewing will be included as an amendment to the bid solicitation.

Due to the vessel's mandate and operational needs, the vessel may be unavailable for some or all of the time allotted to the Vessel Viewing with little or no notice. The Bidder is responsible for all of its expenses associated in participating in the Vessel Viewing.
