Q1. In Annex F, sections 8.3.2.4 and 8.3.2.5:

The weight requirements are stated as 20 lbs. and 10 lbs. respectively for the "supplied equipment". Please clarify whether the weight specifications include or exclude the hardware required in section 8.3.2.4, 8.3.2.5, 8.3.3.4 and 8.3.3.5 to accommodate the "supplied equipment" requirements?

A1. The associated cabling and distribution panels required to accommodate the equipment requirement in section 8.3.2.4, 8.3.2.5, 8.3.3.4 and 8.3.3.5 are not included in the weight stated in section 8.3.2.2 and 8.3.3.2, 20 lbs. and 10 lbs respectively.

Q2. In Annex F, section 8.3.2.2 and 8.3.3.2:

The weight requirements are stated as 20 lbs. and 10 lbs. respectively for the "supplied equipment". Please clarify whether the weight specifications include the weight of servers required to provide voicemail, ACD, management, and reporting?

A2. The weight specifications In Annex F, section 8.3.2.2 and 8.3.3.2 stated as 20 lbs. and 10 lbs. respectively does not included in the weight of external servers used to provide voicemail, ACD, management, and reporting.
