2) Modify Annex A, section 2.2.8.9

Delete (in its entirety): 2.2.8.9

Insert:

2.2.8.9 Contractor must include in their bid an allowance of \$150,000 **for the labour and materials** to complete all localized lead abatement activities during this project. This allowance includes all the subcontractor costs, disposal costs of contaminated waste and contaminated materials. This cost will be adjusted to actual by 1379.

3) Modify Annex A, section 8.5.1.5

8.5.1.5 While the vessel is under the care and custody of the shipyard, the Contractor must have the ship fully secured within the Contractor's controlled facility, where access to the ship, whether in dry dock or alongside at a fit out berth, is controlled through the shipyard's main guard house. The Contractor's controlled facility, including the dry dock and fit out berth, must be fully fenced to prevent access to the ship by the public. The vessel must be under 24 hour video surveillance with automatic recording of the vessel, which must be retained for at least 48 hours. The video surveillance must be able to monitor all access points to the ship, and the ship's lines when alongside the Contractor's facility.

4) Modify Annex A, section 38.3.3.5

Insert:

38.3.3.5 The Contractor must include in their bid the cost to assess all hose connection lines fitted to all of the ships CO2 and FM200 systems aboard the vessel. All hoses older than five years of age, or any hoses determined to be damaged and requiring replacement must be replaced with new Contractor supplied materials. An allowance of \$10,000 must be provided for the labour and material required for hose replacement only, and adjusted via PSPC 1379 process upon final invoicing.

40.3.1.8 Condition of the hydraulic hoses must be noted. All defective hoses must be identified to the TA, and replaced by the Contractor by 1379.
