34. Please confirm excavation for the proposed 150mm topsoil (hydro seeding/turf reinforcement mat area), the Rip rap installation and SSP installation will be paid for under the excavation item.

Answer: Excavation for the proposed hydro seeding / turf reinforcing mat area is covered under the Earth Excavation unit price item. Excavation for rip rap installation is covered under the Gabion Baskets Removal and Vegetation Stripping lump sum item. Excavation for the area where the sheet piles are to meet the existing concrete cut-off wall is covered under the Excavation – Existing Concrete Core Wall / Timber Cribbing unit price item.

35. The top of the proposed sheet piles to be installed into the canal are below the winter water level elevation. Please confirm if the "winter water level" can be lowered to accommodate the installation of the sheet pile or do we have to include for a cofferdam for the installation?

Answer: Winter water levels will not be lowered during construction. As shown on the drawing sections, winter water levels are very low and can be diverted to the east side of the upper reach using sandbags or other minor intervention.

36. The Tender completion date is April 15th, but the local asphalt plants do not open before mid-May at the earliest due to temperatures and half load restriction. Please confirm that the asphalt paving can be delayed to be completed by the end of May.

Answer: Asphalt restoration can be delayed to the end of May.
