#### 5P201-19-0121/A - Infrastructure Renewal at the Operations Compound for Terra Nova National Park, NL.

1) Drawing E-1 there is a note 4 on the drawing but the description is not in the Note section. Please advise?

### Answer: Existing u/g feeders to be disconnected and removed.

2) Drawing E-2 states to remove a pad mount transformer in note 1, which one is to be removed?

#### Answer: Note 1 does not state this. No pad mount transformers are to be removed.

3) Emergency lighting is not indicated and just wondering if there should be?

# Answer: Not required by the NBC,

4) Can you advise as to the interrupting capacity of panels A and B?

#### Answer: 10 kAIC per spec section 26 24 16.01.

5) Will this work take place this year or next as it will determine the costing especially for the temporary power to be supplied?

# Answer: Revised to May 21, 2020 completion.

6) Will the park to pay for the fuel for the generator seeing as how this is replacing power from the transmission line to feed existing buildings?

#### Answer: All fuel, service and maintenance to be included in tender per spec Section 26 05 00 1.11.

7) Is the completion of March 31, 2020 etched in stone?

#### Answer: Revised to May 21, 2020 completion.

8) Specification 1.1 mentions storm water management ponds, recharge gallery, and associated storm and sanitary sewer and manholes. In the drawing package provided, there is no detail for these systems.
