Amendment 002 has been raised to modify the Bid Solicitation as follows:

1. At Part 6, Article 6.2, delete section 6.2.2 – Optional Requirement in its entirety and replace with the following:

6.2.2 Optional Requirement

- a) The Contractor grants to Canada the irrevocable option to acquire the goods, services or both as further described in Annex "A" under the same terms and conditions and at the prices and/or rates stated in the Contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.
 - b) The Contracting Authority may exercise the options by sending a written notice to the Contractor.
 - c) **Option to extend the software maintenance and support services:** The Contractor grants to Canada the irrevocable option to extend the software maintenance and support services period by 1 additional one-year period, exercisable at any time before the expiry of the contract, under the same terms and conditions and at the prices and/or rates stated in the Contract.
 - d) **Option to Purchase An Autoloader:** The Contractor grants to Canada the irrevocable option to purchase an Autoloader as specified in Annex A, exercisable at any time within two years of contract award, under the same terms and conditions and at the price stated in the Contract.
2. At Part 6, Article 6.4, delete section 6.4.1 - Period of the Contract in its entirety and replace with the following:

6.4.1 Period of the Contract

- (a) The period of the Contract begins on the date the contract is awarded and ends two years after delivery and acceptance of the work or the length of the Contractor's or manufacturer's standard warranty period, whichever is longer.
 - (b) The period during which the Contract is extended, if Canada chooses to exercise any options set out in the Contract.
3. At Part 6, delete section 6.4.3 - Option to Extend the Contract in its entirety.

4. At Part 6, **Article 6.6**, delete section 6.6.1 – Basis of Payment in its entirety and replace with the following:

6.6.1 Basis of Payment

Initial Requirement

In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid a firm lot price, as specified in Annex "B" – Basis of Payment for a cost of \$_____ (to be filled in only at contract award). Customs duties are included, and Applicable Taxes are extra.

Optional Requirements

For the option to extend the software maintenance and support services as specified in Annex A, if Canada exercises its option, Canada will pay the Contractor a firm all-inclusive annual lot price as specified in Table "2" (item 2) of Annex "B" Basis of Payment, payable in advance at the beginning of year 2 of the software maintenance period. Customs duties are included and Applicable Taxes are extra.

For the option to purchase an Autoloader as specified in Annex A, if Canada exercises its option, Canada will pay the Contractor, a firm unit price, as specified in Table "2" (item 1) of Annex "B" – Basis of Payment. Customs duties are included and Applicable Taxes are extra.

Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work, unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work.

5. At Annex B – Basis of payment, delete in its entirety and replace with the following:

The Bidder must provide all of the pricing requested in the following Tables in accordance with **Article 6.6.1 - Basis of Payment.**
