Amendment 003

This amendment is being raised to extend the solicitation closing date, make changes to the tender package and answer bidder questions.

A. Bid Closing Date

The closing date for tender 5P420-19-0298/A is extended from October 31, 2019 to **November 5, 2019 at 2:00PM Mountain Standard Time (MST).**

B. Questions & Answers

Please note that the question period has not been extended.

- **Q23**. Please confirm the full amount of top soil and planting are in the parking lot/day use area and not along trail area.
- **A23**. The top soil and planting are in the areas of the parking lot, day use, and restrooms. Depending on the amount of disturbance caused during construction, topsoil or planting maybe required at both bridge abutments and the trail segment between the day use area and the bridge to reinstate the areas to their original condition.
- **Q24**. Is the client intending to keep the rest area open during construction? What is the minimum footprint to be left open?
- A24. The day use area will be closed and the contractor will have full use of the site during the construction period.
- **Q25**. Does the client only require the rest area to have access to the washroom and parking available for those using the washrooms?
- **A25**. The day use area will be closed and the contractor will have full use of the site during the construction period.
- **Q26**. Based on the documents supplied we would like to confirm this is a weathering steel bridge and ask if it would be acceptable to use 350W HSS sections and paint or galvanize the superstructure instead.
- A26. Specification 5 12 23 Section 2.1.1 f requires the bridge structural steel components to be weathering steel. Bidders should conform to the contract requirements and PCA will consider alternatives only after the winning bidder has been selected.
- **Q27**. Will the client be providing picnic tables for the contractor to install?
- **A27**. Yes. Refer to Amendment 001, Specification Section 32 37 00 Exterior Site Furnishings, Part 2 Products.
- **Q28**. Will the client be providing garbage bins for the contractor to install?
- **A28**. Yes. Refer to Amendment 001, Specification Section 32 37 00 Exterior Site Furnishings, Part 2 Products.
- **Q29**. Due to the limited time allowed for construction the ground being frozen and the limited time into summer with the project deadline, would the client allow work during Sundays and long weekends?
- **A29**. Specification Section 01 14 00 Work Restrictions to be amended as per the tender package revisions below (see next page).

C. Tender Package Revisions

1. Specification Section 01 14 00 Work Restrictions, 1.4 USE OF THE WORK SITE/LAYDOWN AREA

Remove:

- .7 The Contractor may undertake construction work during six (6) days per week, with the following restrictions:
 - .a The hours for construction will be 07:00 to 19:00, Monday to Saturday.
 - .b No work during the period of an Alberta or British Columbia statutory holiday long weekend, including one day prior to and one day following the weekend (i.e., no work on Friday through Tuesday if the holiday falls on Monday).
 - .c No hauling of material during inclement weather.

Replace with:

- .7 The Contractor may undertake construction work during seven (7) days per week, with the following restrictions:
 - .a The hours for construction will be 07:00 to 19:00.
 - .b No hauling of material during inclement weather.
