**AMENDMENT #001**

The intent of this amendment is to answer a potential bidder's questions.

**Q1.** What is the typical size of order?

**A1.** The identified user(s) make every effort to place full truck orders but on occasion there could be ½ truck orders. On rare occasions, the identified user(s) may place smaller orders.

**Q2.** What a typical lead time for these orders is? These sizes are custom cut so I would like to ensure we can meet the quantities required in a time acceptable to the user.

**A2.** Lead time varies but on average we expect orders to be processed and delivered within two months from the time vendor receives the call up.

**Q3.** What a typical volume for these call ups is? i.e. would there be one call up against the entire list in the solicitation, or multiple smaller call ups throughout the year?

**A3.** The volume for the call ups varies, but we would not expect the vendor to deliver on all items listed in the solicitation at once. There would be multiple smaller call ups throughout the year.
