This amendment is issued to Solicitation number W0125-20WR08/A to answer the following questions:

A. Questions from Industry and answers from Canada:

Question 1 – How are the two pricing components combined for the financial evaluation (Section 4.1.3)? The example of evaluation in 4.2.1 does not demonstrate how Pricing Basis A and Pricing Basis B in Annex B are combined.

Question 2 - If the objectives of the program as listed in Annex A Section 3.1 *are to safely manage risks of wildlife hazards to aircraft to the lowest reasonably practical level through dispersal and removal of wildlife*, how has the Department of National Defence determined that birds of prey are a required control method for wildlife control at CFB Trenton? Is there a specific reference that the Department of National Defence is using to determine its requirement for the program? Can you provide data that demonstrates that falconry is a required control method?

Response – The Department of National Defence has developed their program based on the experiences and successes using this method of Wildlife Control for this geographic location.

Question 3 - Falconry was not listed as a requirement in the Comox RFP. Can you provide the reasoning for this requirement for Trenton? It seems that meeting the program's objective (Annex A Section 3.1) in a scientifically rigorous manner should be left to the bidder to explain.

Response – This requirement has been developed specific to this Department of National Defence location.

Question 4 – The Solicitation refers to Transport Canada publications TP 11500 and TP 13029. Given that both documents state that falconry can be effective but is not a standalone solution and should be used in conjunction with other tools, how has the Department of National Defence determined the number of hours and consecutive months for this one tool in Annex A Section 6.1?

Response – This requirement has been developed specific to this Department of National Defence location.

Question 5 - Annex A Section 3.1 states that wildlife control will be primarily directed at, but not limited to, the wildlife species listed in 1.2.1. Which of the species listed in sections 1.2.1.1 and 1.2.1.2 require falconry for effective wildlife control and cannot be managed using a combination of other tools?

Response – The species listed in Annex A, sections 1.2.1.1 and 1.2.1.2 are provided as a Background to the requirement. It is not an exhaustive list of all wildlife that may happen upon this location over the course of the Contract, it is provided for reference purposes.
