This amendment is raised to publish question and answer (modify the Request for Proposal) as follows:

Question 17:

With the delivery dates mentioned below, for Year 1 and 2, I would like to know if you will accept delivery of 2,700 + 2,700 lead bars no later than February 28, 2020 since year 1 and 2 both falls in year 2020? Or would you rather require year 2 between February 28 and August 31, 2020?

3.1.7 Best Delivery Date - Bid

While mandatory delivery is requested by as follows:

Year 1 – no later than February 28, 2020 for Items 1 and 2.

Year 2 – no later than August 31, 2020 for Items 3 and 4.

Year 3 – no later than August 31, 2021 for Items 5 and 6; and – no later than February 28, 2022 for Item 7.

Response 17:

- a) 3.1.7 of the Request for Proposal is amended as follows:

Delete:

3.1.7 Best Delivery Date - Bid

While mandatory delivery is requested by as follows:

Year 1 – no later than January 31, 2020 for Items 1 and 2.

Year 2 – no later than August 31, 2020 for Items 2 and 4.

Year 3 – no later than August 31, 2021 for Items 5 and 6; and
– no later than February 28, 2022 for Item 7.

Insert:

3.1.7 Best Delivery Date - Bid

While mandatory delivery is requested by as follows:

Year 1 – no later than February 28, 2020 for Items 1 and 2.

Year 2 – after April 1, 2020 and no later than August 31, 2020 for Items 3 and 4.

Year 3 – after April 01, 2021 but no later than August 31, 2021 for Items 5 and 6; and – no later than February 28, 2022 for Item 7.

- b) 6.4.1 of the Request for Proposal is amended as follows:

For delivery to Her Majesty's Canadian Dockyard location – Halifax,
Item 3 – no later than **to be inserted by PWGSC** 2020.
Item 7 – no later than **to be inserted by PWGSC** 2022.

Note: Delivery for Items 3 and 4 must be after April 01, 2020.
Delivery for Items 5, 6, and 7 must be after April 01, 2021.

All other terms and conditions remain unchanged.
