A1: See Answer #11 in Amendment #3. The type and quantity of amendment required is to be determined by the Contractor.

Q2: Can PSPC provide an area with sufficient footprint to allow for screening? If screened off site can the cobbles be considered as non-contaminated?

A2: The footprint available to the Contractor is shown in the Drawings. As per Specifications 013513.43 1.10.2 "Material and Water will be Classified by the Departmental Representative based on insitu results, field observations, field measurements, and/or ex-situ characterization. Departmental Representative responsible for Classification. Contractor cannot re-Classify material." All material Transported offsite is considered Contaminated and must be Disposed at a Disposal Facility.
