REQUEST FOR QUOTATION AMENDMENT NO. 006

Request for Quotation Amendment no. 006 is raised for the following reasons:

• To address questions pertaining to the delivery timeframe.

Question 10

According to amendment 005, the delivery for Stream 1 is 30 days and the delivery for Stream 2 is 60 days. As you are aware Stream 2 has a specific product DOCK190USZ which is a Targus product – Why the crown is providing Targus an advantage by allowing them 60 days to deliver 1500 units vs any competitor that could win Stream 1 to deliver more than 2200+ units in 30 days?

Answer 10

The delivery time frame of 60 days for Stream 2 was allowed based on the client's operational needs. However after another consultation with the client, the deliveries will only be accepted as follows for Stream 1: 100% or 50% of the total quantity per order 30 federal government working days after the date of contract award and the remaining 50% of the total quantity per order if applicable 60 working days of the federal government after contract award date.

Question 11

The Crown is clearly favoring Targus over other Manufacturers by knowing that delivery deadline of stream 1 cannot be met in 30 days and we are requesting a change to 60-90 days?

Answer 11

Please refer to answer # 10 above.

Question 12

Why the Crown is favoring Targus over other manufacturers by closing Stream 2 to competing products and Making it mandatory as DOCK190USZ ? – It should be open to all manufacturers.

Answer 12

The decision to request a specific product in Stream 2 is based on strict adherence to existing policies. This permission stems from the client's operational needs and the justifications presented.

Question 13

Competitors can provide better pricing and products if given enough time to build stock – Can the Crown change deliveries to 60-90 days?

Answer 13

In order not to put the operations of the clients at risk, the delivery timeframe and quantity presented in answer No 10 above must be respected.

For Stream 2, All Firm Deliverables must be received no later than 60 federal government working days from Contract award.

Options to purchase the additional quantities specified in the Annex B - List of Deliverables and Prices – Optional Deliverables 1 – IRB, ESDC and CBSA Options, may be exercised through SSC IT Pro Order forms at any time during the contract period. For Stream 1, all orders against the Optional Deliverables 1 must be received no later than 30 federal government working days from the date of SSC IT Pro Order form. For Stream 2, all orders against the Optional Deliverables 1 must be received no later than 60 federal government working days from the date of SSC IT Pro Order form.

Replace with:

Options to purchase the additional quantities specified in the Annex B - List of Deliverables and Prices – Optional Deliverables 1 – IRB, ESDC and CBSA Options, may be exercised through SSC IT Pro Order forms at any time during the contract period. For Stream 1, all orders against the **Optional Deliverables** 1 must be received no later than **60 federal government working days** from the date of SSC IT Pro Order form.

For Stream 2, all orders against the Optional Deliverables 1 must be received no later than 60 federal government working days from the date of SSC IT Pro Order form.
