**Question 5:** Page 19 Table A, B & C. There appears to be conflicting information in the tables. Can it please be clarified? The clarification and question in Table A is asking for a waste rate, Table B asks for a cardboard rate, Table C asks for recyclable plastic. The ask on the first line does not correlate to the item number type of material and is asking for a waste rate for and item line recycle item and so on throughout the tables.

**Answer 5:** Annex B – Basis of Payment has been updated to clarify the container type ie. 4 YD FL Container Table A is asking for the container rental fee, the remaining table is specifying the type of waste to be removed. ie. Cardboard versus plastic versus waste.
