**THIS AMENDMENT IS RAISED TO CHANGE THE EVALUATION PROCEDURES AND BASIS OF SELECTION, RESULTING CONTRACT CLAUSES, REQUIREMENT AND FINANCIAL PRESENTATION SHEET. THE FOLLOWING REVISIONS ARE:**

1. At Part 4 – Evaluation Procedures and Basis of Selection, 4.1.2 Financial Evaluation, 4.1.2.2 Evaluation of Price – Canadian / Foreign Bidders, DELETE in its entirety.
2. At Part 6 – Resulting Contract Clauses, 6.4 Term of Contract, 6.4.1 Period of the Contract and 6.4.2 Delivery Date, DELETE in its entirety and REPLACE with the following,

**“6.4.1 Complete Delivery**

The Contractor must make the complete delivery within \_\_\_\_\_ (weeks/calendar days) from the effective date of the Contract.

**6.4.2 Adherence to Delivery Date**

The Contractor will promptly give notice to the Contracting Authority of its inability to meet the contract delivery date and will request therein an extension of time stating its proposed revised delivery schedule and offering consideration for such revisions. Until such notice is received and the revised delivery schedule agreed to, the Minister may, pursuant to the General Conditions, on the business day following the due date of delivery of any outstanding materials, terminate the whole or part of the contract for default.”

3. At Part 6 – Resulting Contract Clauses, 6.6 Payment, 6.6.1 Basis of Payment, DELETE in its entirety and REPLACE with the following,

**“6.6.1 Basis of Payment**

In consideration of the Contractor satisfactorily completing all of its obligations under the Contract, the Contractor will be paid all-inclusive firm unit price(s), DDP Delivery Duty Paid to destination Incoterms 2000, as specified in Annex “B” for a cost of \$ \_\_\_\_\_. Customs duties and excise taxes are included and Applicable Taxes are extra.

Canada will not pay the Contractor for any design changes, modifications or interpretations of the Work, unless they have been approved, in writing, by the Contracting Authority before their incorporation into the Work.”

4. At Part 6 – Resulting Contract Clauses, 6.6 Payment, 6.6.4 Taxes – Foreign-based Contractor, DELETE in its entirety.
5. At Annex “A” – Requirement, 6. Schedule, 6.1, DELETE in its entirety and REPLACE with the following,

“6.1 All products are to be delivered within \_\_\_\_\_ from contract award date.”

**ALL OTHER TERMS AND CONDITIONS OF THE REQUEST FOR PROPOSAL REMAIN UNCHANGED.**
