
12 TYPICAL CONDITION AT PERIMETER - SECTION DETAIL




9 TYPICAL CEILING SLOTTED PANELS - SECTION DETAIL


6 TYPICAL TRANSITION AT MECHANICAL DIFFUSER/LIGHT FIXTURE - SECTION DETAIL


5 TYPICAL CEILING BULKHEAD - PLAN DETAIL


2 TYPICAL SECTION BULKHEAD AT 4M AFF CEILING


1 TYPICAL ISLAND BENCH AT REMOVABLE PARTITION - PLAN VIEW




9 FUME HOOD INSTALLATION DIAGRAM


6 TYPICAL COVER PLATE SD-2 AT CORNER - PLAN DETAIL


5 TYPICAL COVER PLATE SD-1 AT ISLAND BENCH - PLAN DETAIL

4 TYPICAL COVER PLATE SD-2 AT GYPSUM BOARD PARTITION - PLAN DETAIL




9 TYPICAL REMOVABLE PARTITION AT BULKHEAD LEVEL - PLAN VIEW
