Amendment 004

This amendment 004 is raised to provide questions and answers.

Question 1:

We understand that the Standing Offer will be valid for a period of one year. How will the ongoing opportunities subsequent to the initial year be documented for the offeror?

Answer 1:

As per the section of 6A.4.1 Period of Standing Offer

"Any resulting Standing Offer will be valid for a period of one year, and will be renewed automatically unless withdrawn by the Offeror or revised in accordance with the terms and conditions of the Standing Offer."

At the end of first year, if there is no withdrawal or revision of terms and conditions, the period of standing offer will be automatically renewed for another year. If so, the Offeror will receive an amendment to standing offer, to effect the renewal.

Question 2:

What will be the termination rights be for the offeror? Can the offeror terminate the offer by providing Canada 30 days' notice?

Answer 2:

As per the following article of General Conditions 2005 referenced in the RFSO, the Offeror may withdraw if offeror by giving Canada 30 days' written notice.

2005 06 (2014-09-25) Withdrawal

In the event that the Offeror wishes to withdraw the Standing Offer after authority to call-up against the Standing Offer has been given, the Offeror must provide no less than 30 days' written notice to the Standing Offer Authority, unless specified otherwise in the Standing Offer. The 30 days' period will start upon receipt of the notification by the Standing Offer Authority and the withdrawal will be effective at the expiry of that period. The Offeror must fulfill any and all call-ups which are made before the expiry of that period.

Question 3:

According to:

6A.7.2 Proposed rates must remain firm for one year. At annual refreshment, if existing offerors wish to adjust (including change, delete or add) rates in their standing offers, proposed adjustments must be submitted according to the instructions specified in Part 2 and Part 3 of RFSO. If no adjustment is made during annual refreshment, existing rates will remain effective in the following year.

Please indicate, how far in advance of the annual refreshment must new rates be sent to the Standing Offer Authority?

Answer 3:

It depends on the timing of annual refreshment RFSO posting. For example, if closing date of the next annual refreshment RFSO is February 20, 2021, Standing Offer Authority must receive existing suppliers' rate adjustment by then.
