Solicitation Amendment No. 001

This amendment is being raised to provide responses to Requests for Clarification.

- Q1. Will the PowerPoint slides for the Proponents' Conference be made available?
 R1. Yes, they have been posted as an attachment. Please see attached "EN_Proponents' Conference Presentation – Kirkfield Lift Lock".
- Q2. Can a consultant be a Joint Venture with more than one team?
 R2. No, a Proponent cannot submit a proposal as a joint venture with more than one team, submission or proposal. Additionally, a Proponent cannot be included in another Proponent's team, submission or proposal, regardless of whether it is in the form of a joint venture or as sub-consultant or specialist consultant. Please refer to G19 Limitation of Submissions for additional details (copied below for convenience).
- G19 LIMITATION OF SUBMISSIONS**
1. A Proponent may not submit more than one Technical Proposal. This limitation also applies to the persons or entities in the case of a joint venture. If more than one proposal is received from a Proponent (or, in the case of a joint venture, from the persons or entities), all such proposals shall be rejected and no further consideration shall be given.
 2. A joint venture is defined as an association of two or more parties which combine their money, property, knowledge, skills, time or other resources in a joint business enterprise agreeing to share the profits and the losses and each having some degree of control over the enterprise.
 3. An arrangement whereby Canada contracts directly with a prime consultant who may retain sub-consultants or specialist consultants to perform portions of the services is not a joint venture arrangement. A sub-consultant or specialist consultant may, therefore, be proposed as part of the Consultant Team by more than one Proponent. The Proponent warrants that it has written permission from such sub-consultant or specialist consultant to propose their services in relation to the services to be performed.
 4. Notwithstanding paragraph 3. above, in order to avoid any conflict of interest, or any perception of conflict of interest, a Proponent shall not include in its submission another Proponent as a member of its consultant team, as a sub-consultant or specialist consultant.
 5. Any joint venture entered into for the provision of professional services or other services must be in full compliance with the requirements of any provincial or territorial law pertaining thereto in the Province or Territory in which the project is located.
- Q3. Can a consultant be a member of a Joint Venture and also be proposed as a subconsultant on other teams?
 R3. No, as per the response to Q1, a Proponent who is submitting a proposal as part of a joint venture cannot be proposed as a sub-consultant or specialist consultant on other teams, submissions or proposals. Please refer to G1 9 Limitation of Submission for more details.
