This amendment 007 is raised provide questions and answers.

Question 1:

On page 27, Part 6B.2.3 Value of Assets

In point (i) the information is indicated but in point (ii) it is questionable, because normally when the value of the goods is declared and indicated on the order document, according to the law the responsibility is to refund the total amount of the value of the goods. Would you please verify if this article is correct and explain why?

Answer 1:

The following is an example how this article should be used.

6B.2.3 Value of the Goods

- ii) If a declared value is stated on the call-up document, Contractor's standard liability is:
The charge is \$20 per 100 lbs (unit of weight) to a maximum of \$5000.

or

The charge is 2.5% of value to a maximum of \$5000 with a minimum charge of \$2.50.

This article is not an error. This article was reviewed by Risk Assessment expert of Canada.
