### **Amendment 008**

This amendment 008 is raised provide questions and answers.

#### **Question 1:**

We have one question relates to Section 3.1 Offer Preparation Instructions.

As it relates to the Financial Offer, we anticipate that the rate sheets will be quite lengthy. In the spirit of the Canadian Government's Policy on Green Procurement, We request that it forgo the printing of the rate sheets only, and instead provide them to you via soft-copy only. Hard copies would be submitted for all other sections (as well as a soft copy on USB key per the instructions).

#### **Answer 1:**

As per section 3.1 Offer Preparation Instructions

To avoid hard copy, the Offeror may choose to submit its offer electronically via the epost Connect system.

If the Offeror chooses to submit its offer in hard copies, Canada requests that the Offeror provides its Financial Offer as follows:

Section II: Financial Offer (one hard copy and one soft copy on USB key)

If the Offeror chooses to submit its Financial Offer only in soft copy, Canada will consider its Financial Offer if it meets technical criteria. However, after bid closing date if the soft copy cannot be opened, or can be opened but has problem, the evaluation of Financial Offer will be based on the soft copy only.

#### **Question 2:**

Are you able to share what was submitted previously by my firm for the current RFSO in effect?

#### **Answer 2:**

Offers received previously are the property of Canada. Canada will not share them with Offerors. The Offeror should ask the management level of its firm to get a copy of its previous offer. Also, each Requisition for Standing Offer (RFSO) is different. The Offeror should prepare its Offer based on this RFSO, not the previous RFSO.
