Amendment 1 is raised to answer the following questions:

Q1

- a) Could you please confirm the chairs are going to individual desks or in conference rooms?
- b) Will the delivery and installation be all on one floor or on multiple floors?

A1.

- a) Individual desks and open collab areas.
- b) One floor.

Q2. Section 2 of Table 7 indicates the delivery location does not have a loading dock, does not have a lift, that only a person door can be used and that street parking for unloading is required. However, being very familiar with that address, we are aware that there are full loading dock capabilities for Phase III at Place du Portage.

Could you kindly confirm the delivery logistics for this solicitation? Is there anything particular about the room in which the chairs will be installed that makes it otherwise inaccessible from the main loading dock? These are critical variables in the calculation of time required to unload and install the products.

A2. PDPIII has full loading dock capabilities and freight from loading dock goes directly to the 16th floor.
