Amendment 010

This amendment is raised to request additional information related to the CHER Project and to advise Industry that the Request for Information (RFI) is being extended to March 30, 2020 in order to engage further with industry.

The CHER project team has received an invitation to attend a 2-day factory tour including an equipment demonstration at an industry site. To ensure fairness, we are canvassing for industry interest in having 3-5 members of the CHER team visit your site for a one or two days. To ensure value to Canada, an industry visit should involve a live in-person demonstration of CHER-type and sized equipment.

Please respond by 17 December 2019 if you are interested in hosting a site visit for the CHER project team. Visits would take place in the first half of 2020 at a mutually convenient time. The decision on whether to visit any industry sites will depend on whether the project has sufficient staff and budget to satisfy all invitations. Invitations received after 17 December 2019 may be declined.

During the visits, the CHER project team would be interested in learning about: existing equipment performance, future innovations, capabilities to integrate militarization (where applicable), capabilities to integrate armouring/vehicle protection (where applicable), capabilities to provide in-service support, and capabilities to provide integrated logistics support. During the visits, the CHER project team will not be able to: discuss the draft Request for Proposal (RFP); address any financial, contractual or bidding issues; or answer any project-management related questions about the CHER project. These may only be discussed in Ottawa-based one-on-one meetings in the presence of the Fairness Monitor.

Ottawa-based one-on-one meetings may be requested at any time during the RFI period and will be scheduled based on mutual availability. We can accommodate in-person, tele conference or video conference participation.

Participation in site visits or any other discussions is not mandatory and will not affect the availability for suppliers to participate and follow-on procurement activities related to the project. The rationale for these visits is to benefit the quality and technical content of the procurement documentation only and will not impact or influence the evaluation of any bids.

All other terms and conditions remain unchanged.
