1) To answer additional enquiries received from potential bidders:

Question No. 2 Re Microwave Digestion System – Item B1.1 “Be able to process a minimum of 12 samples in each run”: Would a system that process 10 samples per run be considered if it meets all other requirements?

Answer: Yes, a minimum batch size of ten (10) samples is acceptable. Criterion B1.1 has been revised accordingly. See below.

B1.2	Be able to monitor sample temperature of each vessel in real-time		
B1.3	Hardware interlocks to ensure safety during operation		
B1.4	Be able to be controlled and operated with the lab's existing computers running Windows 7 professional service pack 1		
B1.5	Be able to digest high (≥ 3 g) and low sample amounts (≤ 0.1 g) as well as high (≥ 50 mL) and low sample volumes (≤ 100 μ L)		
B1.6	The instrument to include all necessary wiring, connectors, vessels, and fittings for complete turn-key system installation and testing.

B2.1	Designed for unattended operation and must be fully integrated with the workstation		
B2.2	The instrument to include all necessary wiring, connectors, tubing, and fittings for complete turn-key system installation and testing.		
B2.3	The system must be supplied with any specialized tools, tool kit(s) or maintenance manuals necessary for maintaining routine operation by DFO		
B2.4	By indicating "met", the supplier agrees to provide pre-installation site specifications to ensure site-readiness for installation. The Contractor must identify in its bid all SITE REQUIREMENTS including bench space, temperature and operating range, electrical connections (voltages and numbers), gases and regulators required, and other special requirements (venting, etc.)		
B2.5	The System must be powered by either 115V or 208V AC 50/60Hz power or must include equipment for conversion to compatible voltage.		
B2.6	All electrical equipment supplied under the Contract must be certified or approved for use in accordance with the <u>Canadian Electrical Code</u> , Part 1, before delivery, by a certification organization accredited by the Standards Council of Canada. The bidder agrees to submitting a certificate evidencing compliance with this requirement upon request from the Technical Authority.		
B2.7	Performance Verification: Documentation demonstrating compliance with the performances requirements detailed in part 1 of Section B must be provided (Printed Paper of .PDF file) after system installation and training for on-site acceptance by the DFO Technical Authority.		
B2.8	A minimum of one (1) day training for 2 operators is required and to be completed simultaneously with installation/validation testing. Training to be scheduled during standard work hours, approximately 9:00 am – 4:30 pm, Monday-Friday for a minimum 7 hours/day Training to include usage instruction on all software and hardware components, routine maintenance requirements and equipment troubleshooting.

B2.11	The warranty period will not start until all deliverables have been completed to the satisfaction and acceptance of the DFO Technical Authority.		
B2.12	On-site warranty and maintenance service by authorized Factory Service Representative (FSR) must be available within five (5) calendar days of a service request.		
B2.13	Telephone support service calls must be responded to within one (1) calendar day of a service request		
B2.14	As part of the one (1) year warranty service support required with the system, the Contractor must provide access to application chemists trained in the use of microwave digestion systems to provide assistance in method development and application support pertaining to the microwave digestion system delivered and installed by the Contractor pursuant to this contract. Access may be by telephone or on-line and must be responded to within three (3) calendar days of a service request
