CLARIFICATIONS

- A. Parks Canada will be renting the 5plex suites out at a cost of \$1,150/month for the 1 bedroom suite and \$1,400/month for the 2 bedroom suites. The contractor is to ensure that the contract completion date is met, to avoid a loss of income to Parks Canada.

QUESTIONS and ANSWERS

- Q₁ The general receptacles in the suites are all marked as IG receptacles according to the symbol schedule. Can we clarify if this is the intent as opposed to “Tamper Proof receptacles” which would be the norm?
- A₁ The symbol legend is incorrect. These are to be tamper proof, Arc Fault receptacles (or receptacles protected by arc fault breakers). Refer to note ‘J’ and ‘K’ on electrical drawings E2.0, E2.1 and E2.2 for additional information.
- Q₂ The exterior light fixture type on the service side of the building in drawing E2.1 are not indicated as to which type. Are they to be type 306, or 307?. Please confirm.
- A₂ These are Type 307.
- Q₃ Earth work; geotechnical report is not available for this project. Please provide Geotechnical Report and/or can we ask for cash allowance to cover geotechnical engineering assessment/report and all unforeseen work required to excavate or remove all rocks and adequately provide sufficient backfill. It will be very hard to price this scope if Geotech is not available. Please, confirm.
- A₃ There is no geotechnical report for this site.
- Q₄ Temporary cribbing; specification is required. Please, provide.
- A₄ It is the general contractor’s responsibility on means and method to provide cribbing as necessary.

- Q5** Horizontal blinds; confirm if all exterior windows to have horizontal louver blinds. Locations are not designated on the drawings. Please, confirm.
- A5** All windows require horizontal louver blinds.

- Q6** Specification; Section 06 73 00; Composite Decking; product name and specification is required. Please, confirm.
- A6** Specifications are performance based. Any product that meets the requirements outlined in the specification is acceptable.
-
- Q7** Specification; Section 07 44 56; Cementitious Siding; product name and specification is required. Please, confirm.
- A7** Specifications are performance based. Any product that meets the requirements outlined in the specification is acceptable.
-
- Q8** Specification; Flooring; (Ceramic tiling; resilient flooring; vinyl plank and rubber base); product name and specification is required. Please, confirm.
- A8** Specifications are performance based. Any product that meets the requirements outlined in the specification is acceptable.
-
- Q9** Specification; Section 01 45 00; page 1 of 3; Item 1.2.2; all testing to be engaged and paid by General Contractor. Please, confirm.
- A9** The general contractor is required to do all necessary compaction testing to ensure that work meets contract specifications. Copies of the test results are to be submitted to the Departmental Representative to demonstrate that all fill and backfill areas have been properly compacted in accordance with the specifications. Concrete compressive testing is not required by the contractor. The owner may do additional Quality Assurance testing to verify the contractor's results.
