## **PART 1 - GENERAL INFORMATION**

### **1.1 Requirement**

The requirement is detailed under Article 6.1 of the resulting contract clauses.

### **1.2 Debriefings**

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

### **2.4 Applicable Laws**

## **PART 3 - BID PREPARATION INSTRUCTIONS**

### **3.1 Bid Preparation Instructions**

### **4.2 Basis of Selection**

## ANNEX ``A``

### STATEMENT OF REQUIREMENT

#### Background

Routine organic and toxic contaminant analyses on various matrices is carried out to support various research programs at the Centre and also across other centres. To prepare the sample extracts for analysis using analytical equipment, solvents from the extracts are evaporated and/or concentrated to a predetermined volume **from** 25 ml to 0 mL and **from** 25 mL to 0.3 mL. To achieve this step accurately, rapidly, and in a reproducible manner, a sample extract parallel evaporator is needed/required.

#### Objectives

Agriculture & Agri Food Canada (AAFC) – Morden Research & Development centre requires a sample extract parallel evaporator to gain the ability to further their research.
