PART 1 - GENERAL INFORMATION

1.1 Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 epost Connect service

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

This email address is to be used to open an epost Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through an epost Connect message if the bidder is using its own licensing agreement for epost Connect.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 5 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in _____ (*insert the name of the province or territory*).

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

- If the Bidder chooses to submit its bid electronically, Canada requests that the Bidder submits its bid in accordance with section 08 of the 2003 standard instructions. The epost Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Financial Evaluation

The bidder must submit its bid pricing in accordance with and meeting all of the compatibility requirements detailed in Annex "A" – Requirement/Basis of Payment, in Canadian funds. Pricing must be provided for all line items. Only one contract will be awarded as result of the solicitation.

Bids will be evaluated based on the prices detailed in Annex A – Requirement/Basis of Payment. The price used in the evaluation will be the Total Firm Price which is calculated as follows:

Total Firm Price is the sum of Firm Unit Prices multiplied by quantities for line item.

4.2 Basis of Selection

- 4.2.1** A bid must comply with all requirements of the bid solicitation to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

ANNEX "A" REQUIREMENT

Rugged Cargo Boggan

Background

The Grey and Simcoe Foresters are tasked with the ARCG (Arctic Response Company Group) Mission task. And thus responsible to maintain a large amount of specialized equipment in order to fulfill its Mission Task within its notice to move timings (4 days for Recce, 8 for Main body). We have conducted deliberate deployments on multiple occasions to Northern Ontario specifically, where due to the climate and terrain we have relied on the use of rugged fibreglass/plastic framed cargo Boggans to be towed behind snowmobiles for almost 5 years. The fibreglass or plastic construction with a solid metal tow bar allows for ease of movement in soft snow as well as durability on hard ice surface where it can be subject to hard hits on ice and rock. Historically we have relied on "Equinox" Boggans and they have worked well to suite our needs however our current fleet of Boggans have been subject to significant wear and abuse over the past 5 years and as such have been declared "BER".

Specifications

To be considered compliant, bidders **MUST** meet the following requirements in the model of Boggan that they offer:

- (7) Plastic/Fiberglass construction, Length: 105-107", Width: 35-37", Depth: 14-18", Hitch Style: 1-Piece/drop hitch (compatible with J style hitch)
- (36) Plastic/Fiberglass construction, Length: 106-109", Width: 36-38", Depth: 24-26", Hitch Style: 1-Piece/drop hitch (compatible with J style hitch)
- Each Boggan to come with 2" Polyethylene runners (2 per Boggan with hardware)
- Method of securing cargo (cargo rails, hardware, cover w/ tie down/bungee per Boggan)
- Able to withstand being dragged over hard and deep-soft ground
- Approximate weight capacity of 500lb
- Tow bar and hitch and assembly must be able to attach and fit to J style Hitch (drop hitch)

Must provide:

- One (1) Copy of the Operating Manual for all installed equipment;
- Two (2) Copy of the Servicing Manual;
- Two (2) Copies of the Parts Manual; and
- One (1) Copy of Manufacturer's Warranty for all installed equipment.

The Boggans must arrive with minimal assembly required. The Boggans will be delivered to CFB Borden where an OPI will be ready to receive. OPI must be contacted 1 day prior to delivery to confirm time and location and will be present to conduct the acceptance inspection to ensure all mentioned requirements have been met.
