Q16. What is the loading capacity/thickness of the courtyard slab? I assume there is a parking garage under the courtyard, thus making it a suspended slab and possibly needing shoring underneath to carry the load of the scaffolding required in the courtyard.

A16. The courtyards have been scaffolded numerous times in the past to facilitate projects and there should be no concern with doing so during this project. Additionally, the recent 'urgent window repairs project' required the use of scaffolding.
