Invitation to Qualify (ITQ) for Third National Shipbuilding Strategy (NSS) – List of Qualified Suppliers

On August 2nd, 2019 Canada published the Invitation to Qualify (ITQ) F7013-190036/B as the first phase of the procurement process for the selection of a third Canadian shipyard. Respondents were invited to participate in order to qualify and be short-listed. Interested suppliers were also informed that only Short Listed Respondent (SLR) would be invited to the follow-on Request for Proposal (RFP) competitive process.

With the completion of the ITQ Phase and in accordance with the ITQ terms, Canada is publishing the list of SLR:

- 1) Chantier Davie Canada Inc.

This shipyard will now be moving to the next stage in the competitive process, which is a Request for Proposal (RFP) and evaluation stage. This will include a third-party assessment of the shipyards' infrastructure, submission of a formal proposal, and a financial due diligence process to ensure they are financially capable of performing the work and making any necessary upgrades to their infrastructure. Once this phase is completed, the Government of Canada will begin negotiations with the successful shipyard for a potential umbrella agreement. It is expected that the addition of the third strategic partner to the National Shipbuilding Strategy will be announced in 2020.
